Well was originally completed in the Delaware from perforations at 8534-48' and 8558-70' in March 2000. Due to low production (11 BOPD & 113 BWPD) additional Delaware perforations were made on May 2, 2000. The Delaware was perforated from 8490-8508' 2 SPF and was not stimulated. Delaware perforations were then added at 7948-62' and 8074-78' 2 SPF. These perforations were stimulated with 1000 gals of 7 1/2% HCl and were frac'd with 15,000 gals and 46,000# 16/30 sand. The well is presently producing 23 BOPD and 234 BWPD.
