The APD submitted requested that the 5 1/2" casing (production) be cemented back to 600' above the highest productive interval. This had been approved on all previous wells in the area with the BLM stipulation being "The minimum required fill of cement behind the 5 1/2" production casing is to cover and seal all possible hydrocarbon producing (intervals) by 500 feet or tie back to the 8 5/8" by 200 feet". Echo requests this same stipulation be used on the subject well. The present stipulation states "The 5 1/2" production casing is planned to be tied back to 8 5/8" casing by at least 150 ft.
