Cmt 1st stage w/340 sx 15:61:11 (Poz-C-CSE) + 1/4 pps celloflake + 3 pps gilsonite, circ 4 hrs, 130 sx to pit, cmt 2nd stage w/ 425 sx 35:65:6 (Poz-C-gel) + 1/4 pps celloflake + 3 pps gilsonite lead and 150 sx Class C tail, bumped plug at 7:30 pm, cmt top from bond log - 2250'.
