- ③ Circ. hole full of 9.0 ppg brine (pkr fluid).
- ④ Rig down.

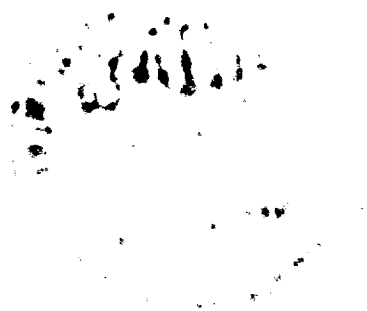
