It is intended to drill a well with rotary tools at the above location to an estimated TD of 4640'. Casing will be set in accordance with USGS regulations and other special requirements will be complied with.

The following casing pattern is planned: 8 5/8" set at 700' with approximately 400 sacks, cement to return to surface; 4 1/2" set at 4640' with approximately 170 sacks, cement to return to 4000'.

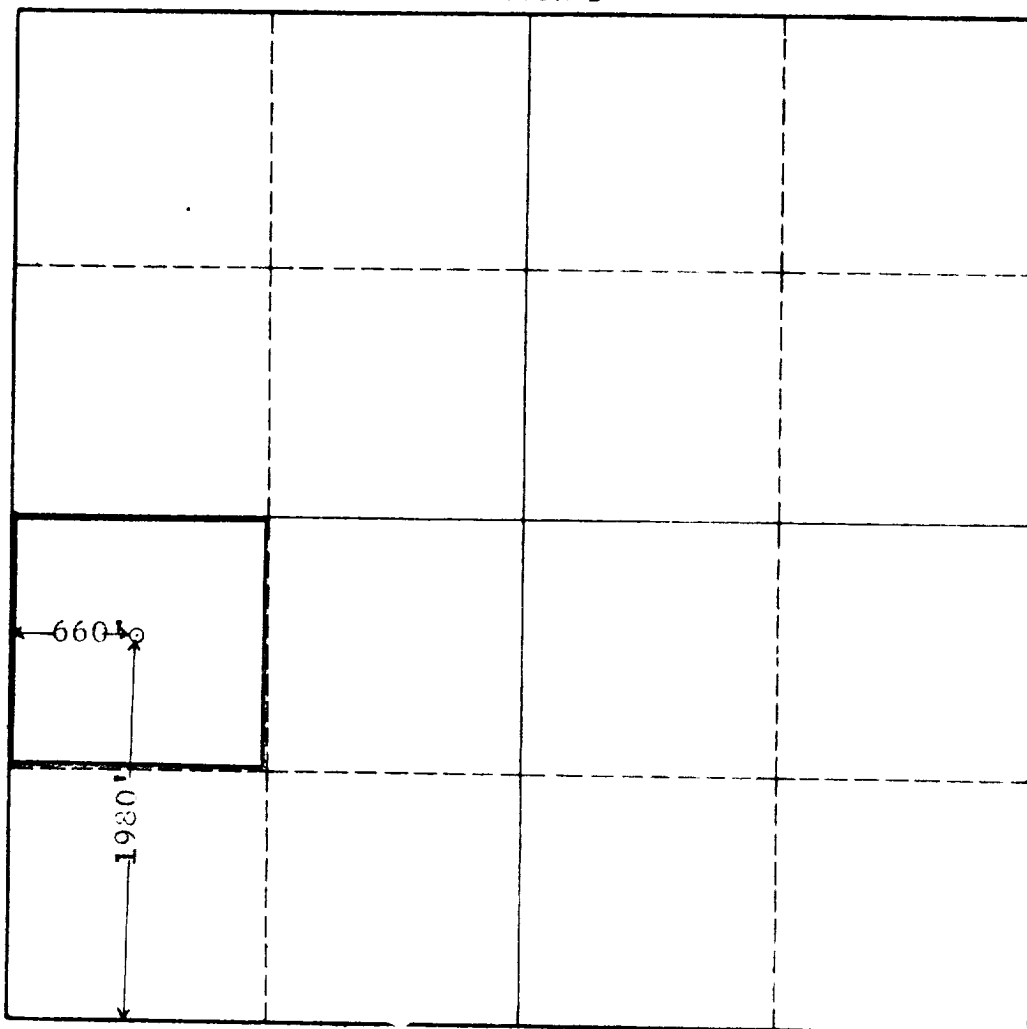
