DETAILS OF WORK

The following casing pattern is planned: 7 5/8" casing set at 700' with 400 sacks, cement to circulate; 4 1/2" casing set at 4715' with 170 sacks, cement to return to 4000'.

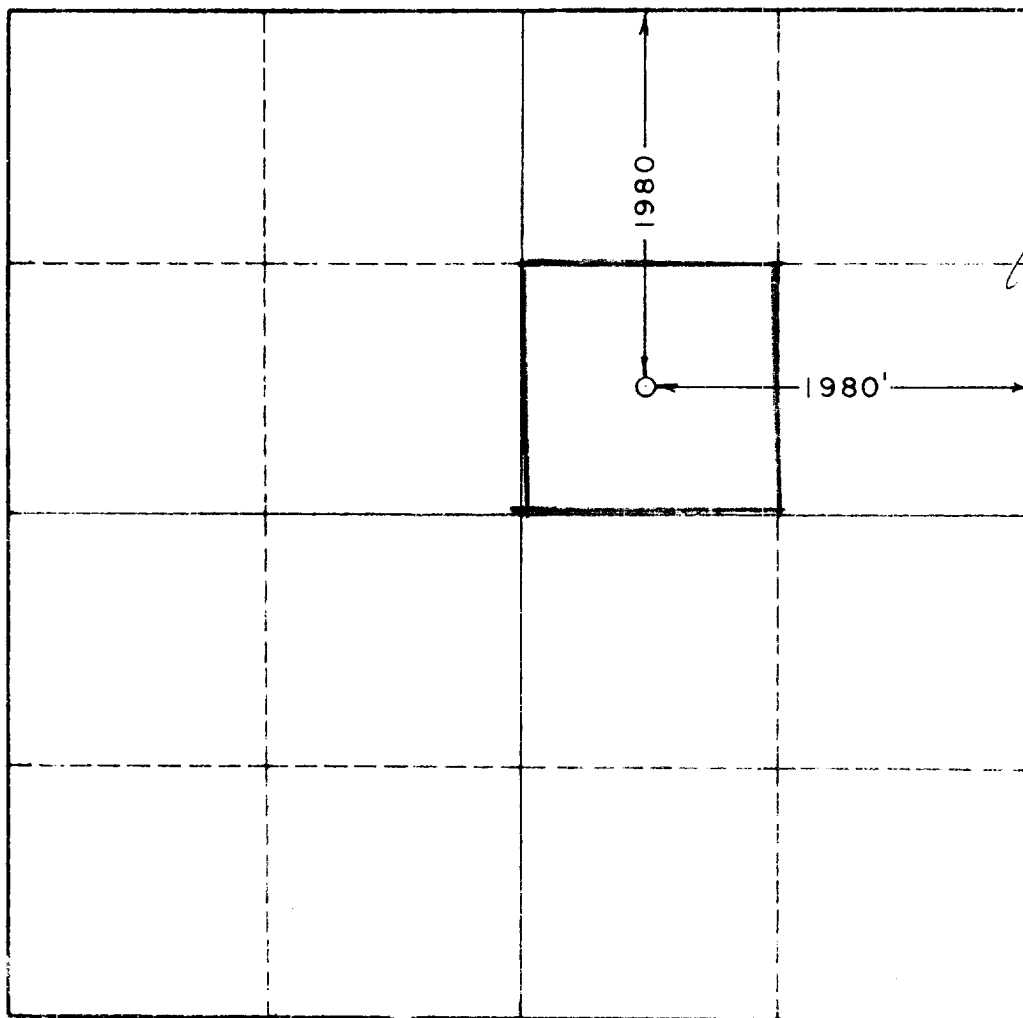
