The following casing program is planned: 7 5/8" OD set at 350 with 175 sx, cement to circulate to surface; 4 1/2" OD set at 4605' with 750 sx, cement to return to top of salt.

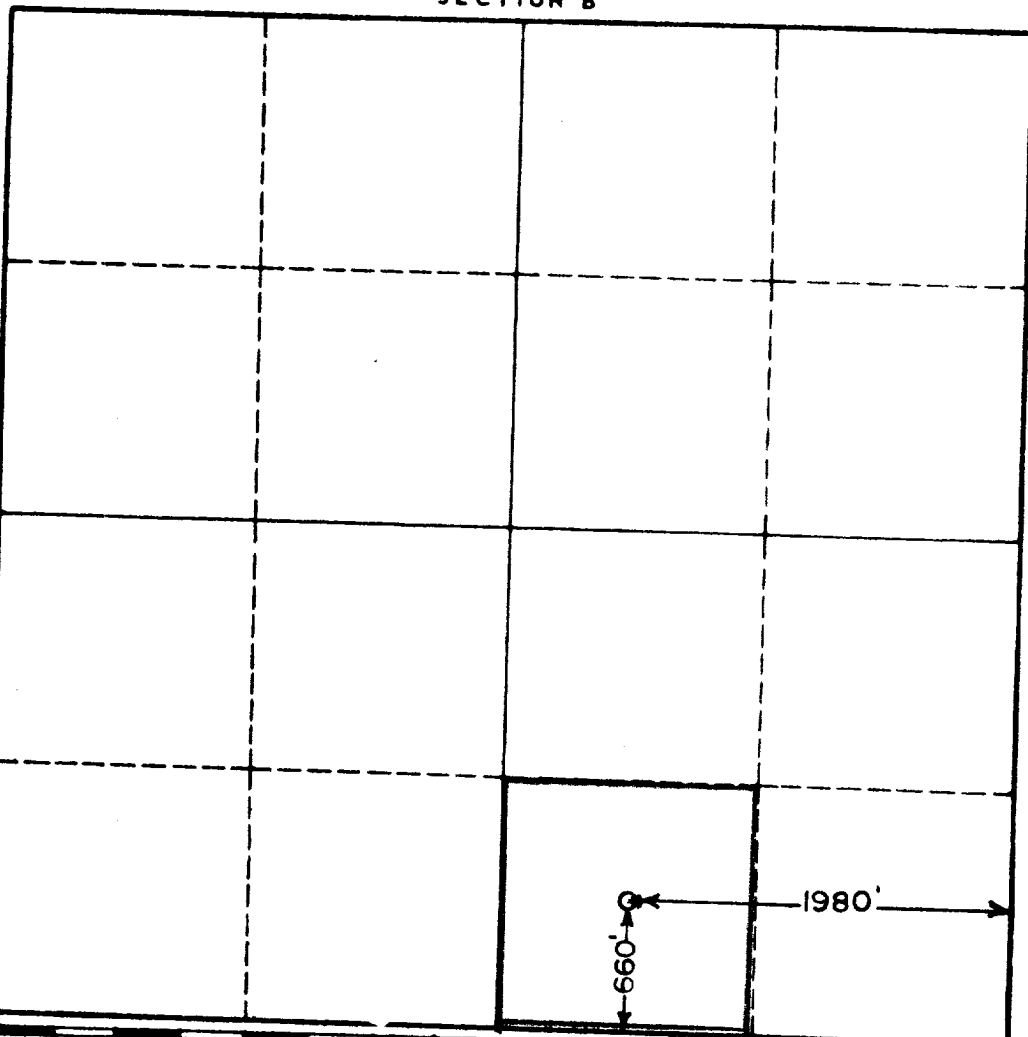
