It is intended to drill a well at the above location with rotary tools to a depth of 4620' in the Delaware Sand. Casing will be cemented in accordance with USGS regulations and other special requirements will be complied with.

The following casing program is planned: 7 5/8" OD set at 350' with 175 sx, cement to circulate to surface; 4 1/2" OD set at 4620' with 800 sx, cement to return to top of salt.

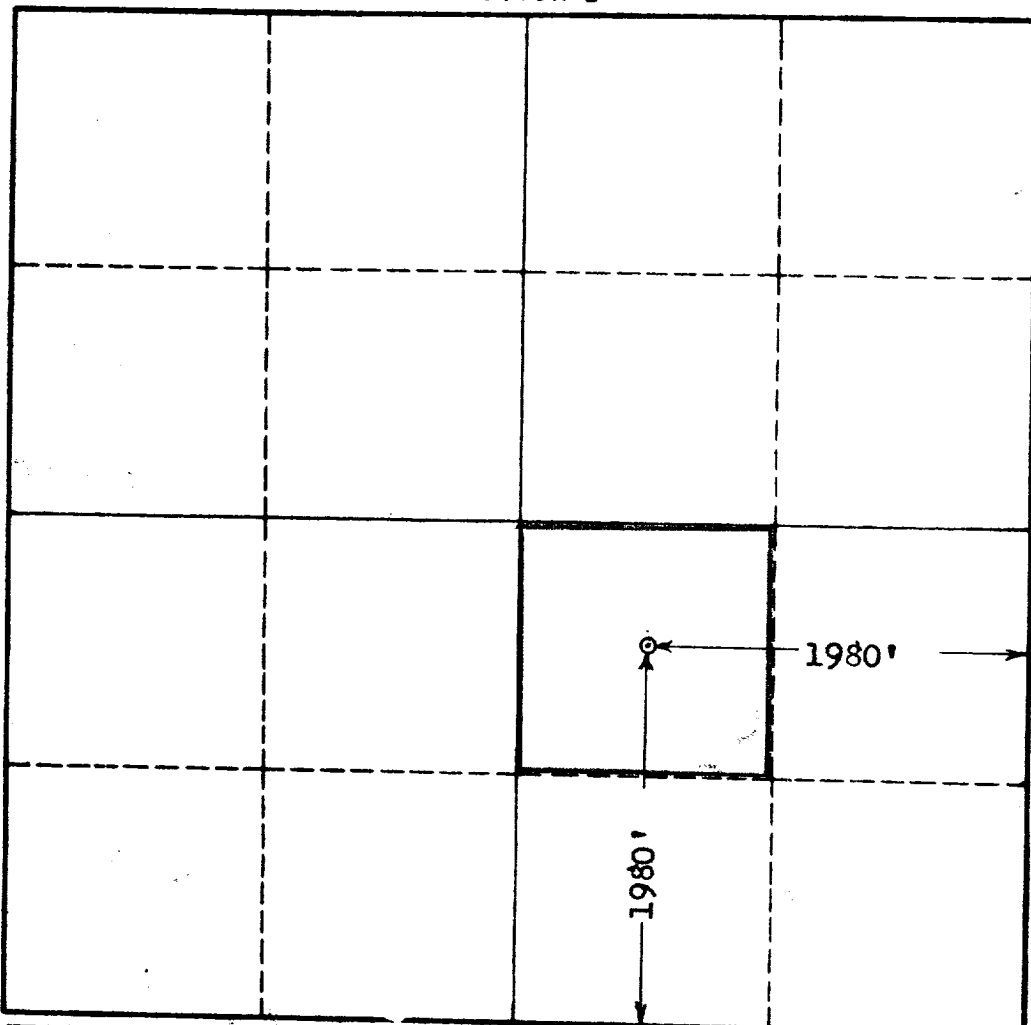
