**FULL DETAILS OF PROPOSED PLAN OF WORK**  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Unseat packer, pull tubing.
2. Run Neutron log.
3. Run Baker model 400-N Bridge plug on wire line and set at 4606'.
4. Pressure up annulus with oil to check bridge plug
5. Run tubing with packer
6. Spot 250 gallons mud acid on bottom. Set packer at 4500'.
7. Perforate with thru tubing swing jet, 4 holes per foot 4588--4604'.
8. Displace acid into formation.
9. Frac with 1000 gallons oil and 1000# sand.
10. Unseat packer, circulate to bottom, set packer.
11. Install X-mas tree, swab well on production.
