Oct. 22, 1992

Rigged up Permian Servicing Well Servicing unit, COH w/ rods and down hole pump, put on BOP, Visually inspected casing near the surface with flashlight and mirror , no apparent damage. Could see 100' down hole when sun was right; no pack off seal assembly found on top of slips, pumped into annulus. Casing not leaking, annulus full. Called for new seal assembly.

Oct. 23, 1992

GIH w/ lockset bridge plug and packer, set plug @ 4885 set packer @ 4850, tested plug to 500#, for 5" held ok, moved packer to 2400; tested pipe to 500# for 5", held ok, moved packer to 1900', tested pipe to 500# for 5" held ok, COH w/ packer. GIH w/ tension packer to 100' tested pipe above and below 100' to 500# pipe held fast. Reset packer at surface just inside 4 1/2 casing, tested whole string to 500# for 5", held ok, LD packer, GIH w/ on-off tool to pull plug, pulled plug and COH w/ tools and plug, laid down same. Put primary seal and secondary seal into wellhead, picked up and set tension packer 10' inside 4 1/2, closed BOP tested wellhead and top 10' of casing to 550' for 10" held ok. See copy of pressure chart.

Bled off pressure opened BOP, released packer, laid down tools closed well in for night. Called BLM in Hobbs prior to test of wellhead and recieved approval of test proceedure.

Oct. 24, 1992

Ran back, tubing, rods and down hole pump. Put well back on production.

Oct. 25, 1992

Well back on production making 4 BO, 6 BW GOR 800/1 all equipment functioning properly.
