DETAILS OF WORK

It is our intention to drill Goedeke No. 3 at above location which is 25' South of the plugged and abandoned Goedeke No. 3-X. Verbal approval was obtained from Mr. Jack Gordon on 10-16-62. It is proposed to drill the well to an approximate depth of 5200' to attempt a completion in the Delaware horizon. All casing points will be cemented in accordance with approved methods of the U.S.G.S. and any special requirements will be complied with. It is planned to use the following casing pattern: 11" hole, 7 5/8" casing to be set at 384' and cemented with 250 sacks cement. Cement is to circulate. 6 3/4" hole, 4 1/2" casing to be set at 5200' and cemented with 200 sacks cement. Cement is to return to 3800'.

Permission is requested to produce the well upon completion.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

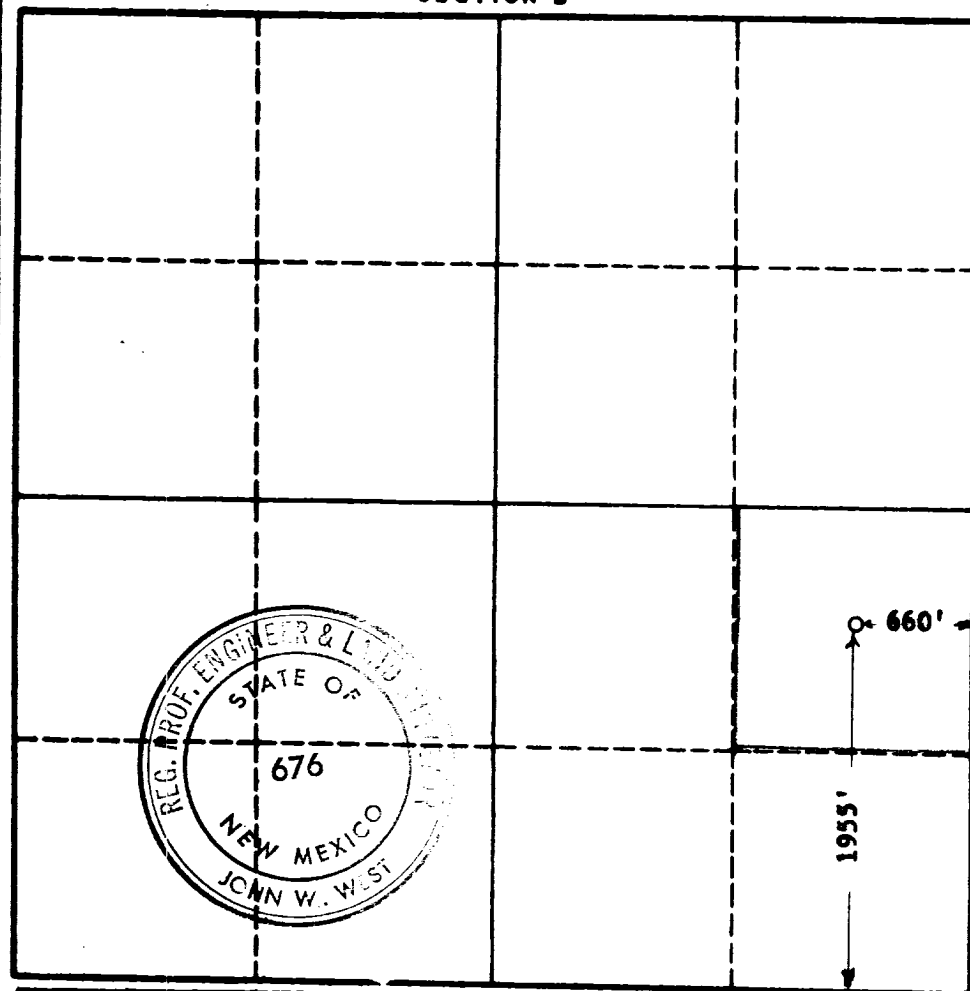
