- ② Set CIBP @ 4590'. Test CIBP to 1000 psi. Load & press. test csg to 600 psi for 15 minutes. If csg doesn't test, a sg2 procedure will follow.
- ③ Circ. hole full of 9.0 ppg brine (pkr fluid).
- ④ Rig down.
