### DETAILS OF WORK

It is proposed to drill with rotary tools at the above location to approximately 5600 feet for a Belmore test. Surface casing to be 8 5/8" 24# set at 300 feet, cement circulated to surface. In the event commercial production is obtained 4 1/2" 9.5# casing will be set at total depth and cemented with 200 sacks.

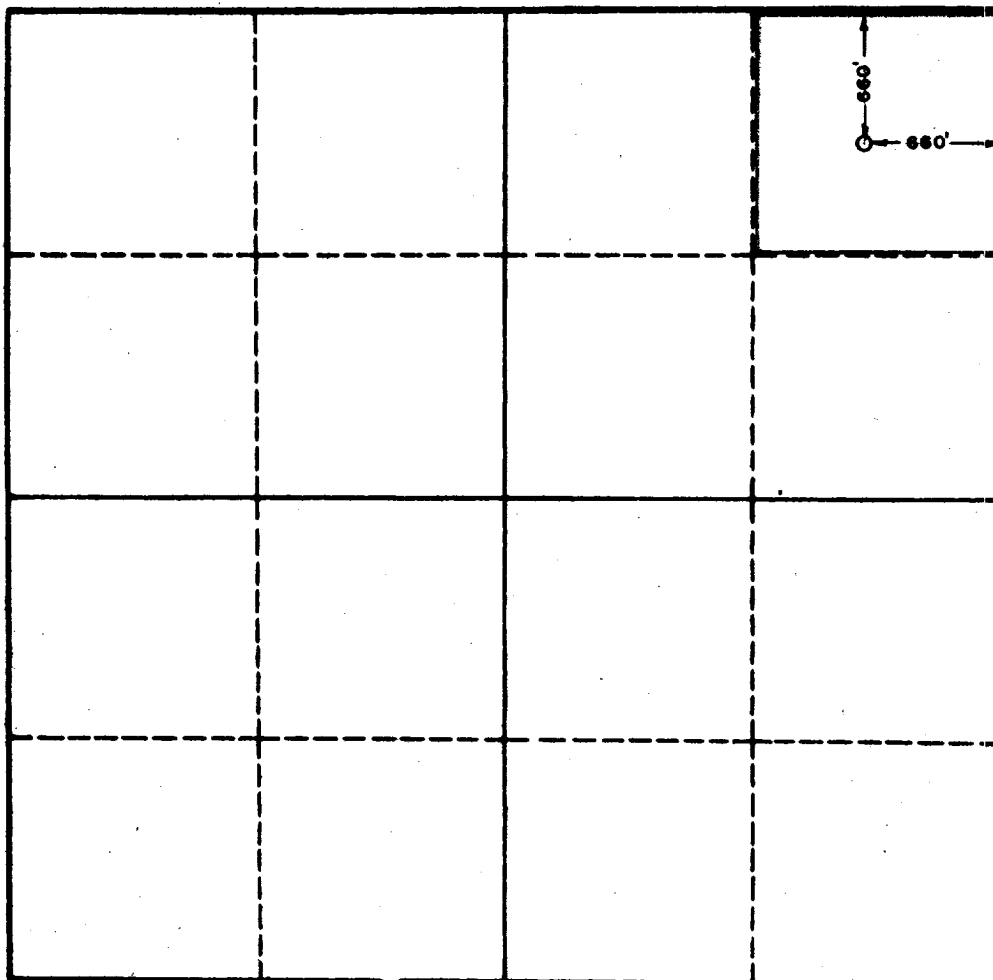
