Circulated cement down 8-5/8" casing and up 8-5/8"/12-1/2" annulus. Pumped 200 sx class C cement. Cut 8-5/8" and 12-1/2" casing 3' below GL. Cut and removed deadmen. Installed P & A marker. Cleared location of all junk.
