- 4/6/92 - MOVE IN, RIG UP, PICK UP AND TALLY 2 3/8" TUBING, TAG CEMENT ON TOP OF CAST IRON BRIDGE PLUG AT 3325', CIRCULATE HOLE WITH MUD, PULL TUBING TO 2820' SPOT 12 SACKS OF CEMENT AT 2820', PULL TUBING UP HOLE, SHUT DOWN.
- 4/7/92 - TAG CEMENT AT 2650', PULL TUBING OUT, PERFORATE WELL AT 1250' RUN TUBING TO 1250', CIRCULATE WELL UP 8 5/8" TO SURFACE, PUMP 200 SACKS OF CEMENT FROM 1250'-SURFACE IN 8 5/8", SPOT 12 SACKS OF CEMENT IN 5 1/2" FROM 1250' UP, PULL UP HOLE, WAIT FOUR (4) HOURS ON CEMENT, RUN TUBING BACK IN HOLE, DID NOT TAG ANY CEMENT, TEST CASING TO 500#, SPOT 15 SACKS OF CEMENT FROM 1250' UP, PULL TUBING, SHUT DOWN.
- 4/8/92 - TAG CEMENT AT 1058', PULL TUBING TO 365', CIRCULATE 40 SACKS OF CEMENT TO SURFACE IN 5 1/2", CUT OFF WELLHEAD, INSTALL MARKER, FILL COLLAR WITH CEMENT, RIG DOWN, MOVE OFF.
