Spot 40 sx Class C 2990'-2310'. PUH to 1330'. Spot 19 sx cmt from 1330'-1147'. FODH w/tbg. Perf 5 1/2" csg @ 241'. Circ to surf w/40 bbls P&A mud. Pump 54 sx cmt down 5 1/2" csg up 5 1/2" x 7 5/8" annulus. Did not circ to surf. Pump 25 sx cmt down 5 1/2" x 7 5/8" annulus. Cut off wellhead. Fill up csg w/cmt to surf (2 sx). Install P&A marker.
