Total depth 3731' lime. It is proposed to plug and abandon this well. Drill Stem Test #1 was run with packer set at 2960', tested 79' with no show of oil or gas. Drill Stem Test #2 wasmade from 3138' to 3225' (tested 87') small show of gas and no oil Drill Stem Test #3 was made from 3548' to 3589' (41') tested with no show of oil. Drill Stem Test #4 was run from 3591' to 3639' (48' tested) with no show of oil or gas. Drill Stem Test #5 was run with packer set at 3709' (tested 22') with slight show of gas, no cil and recovered 120' of sulphur water. Since there were no show of oil and small shows of gas, it was decided to plug and abandom as follows: Spet 25 sacks of cement at 3700', 25 sacks at 1200'; and cement at surface with 25 sacks. P & A cite is to be marked as required.
