Figure 1. The structure of the proposed model. The model consists of three main parts: a feature extraction module, a classification module, and a fusion module. The feature extraction module uses a 3D CNN to process the input data. The classification module uses a 2D CNN to process the output of the feature extraction module. The fusion module combines the outputs of the two modules to produce the final result.
