

- (c) That the applicant proposes to produce the well through the tubing-casing annulus as a gas well in the interval between the bottom of the 7" casing at 3256' and the upper formation packer at 3429'. This interval will be in the Seven Rivers formation and will conform with the vertical and horizontal limits of the Jalmat Gas Pool.
- (d) That pressure tests on November 1, 1955 showed the top packer to effectively separate the two zones. This packer test was witnessed by Mr. Rieder and Mr. Armstrong with the Commission.
- (e) That the applicant will maintain pressure checks to see that continued separation of the zones is obtained.
- (f) That the granting of this application for permission to produce this well as a dual completion is in the interest of conservation and the protection of correlative rights.
