1. Rig up pulling unit and install BOP.
2. Pull tubing and packer.
3. Clean out open hole to 3700'.
4. Run acoustilog TD-3000'.
5. Run 4 1/2" 9.5# K-55 liner and set 3100'-3700'.
6. Cement liner.
7. WOC 24 hrs.
8. Drill out cement and test liner top.
9. Selectively perforate the Queen.
10. Acidize with 3000 gallons 15% Acid.
11. Run packer on plastic coated tubing and set within 100' of top perforation.
12. Place well back on injection.
