Reference is made to your application dated March 6, 1995 for a 120-acre non-standard gas spacing and proration unit consisting of the following acreage in the Jalmat Gas Pool:

LEA COUNTY, NEW MEXICO
TOWNSHIP 24 SOUTH, RANGE 36 EAST, NMPM
Section 13: N/2 SW/4 and SW/4 SW/4


It is my understanding that this unit is to be simultaneously dedicated to your existing Cooper Jal Unit Well No. 303 (API No. 30-025-09556), located at a previously approved unorthodox gas well location [see Rule 2(b)2 of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended] 2310 feet from the South and West lines (Unit K) of said Section 13 and to your existing Cooper Jal Unit Well No. 107 (API No. 30-025-09558), located at an unorthodox Jalmat gas well location for the subject 120-acre unit 1650 feet from the South line and 1980 feet from the West line (Unit K) of said Section 13.

By authority granted me under the provisions of Rules 2(a)4 and 2(c) of the Special Rules and Regulations for the Jalmat Gas Pool, as promulgated by Division Order No. R-8170, as amended, the above-described unorthodox gas well location for the Cooper Jal Unit Well No. 107 and 120-acre non-standard gas spacing and proration unit are hereby approved. Further, you are hereby authorized to operate the above-described non-standard gas spacing and proration unit, with allowable assigned thereto in accordance with Rule 5 of said special pool rules based upon the unit size of 120 acres.

This order supersedes the previously approved 160-acre non-standard Jalmat gas spacing and proration unit comprising the SW/4 of said Section 13, in which the Cooper Jal Unit Well No. 303 was dedicated, therein authorized by Division Order No. R-520, dated August 12, 1954.
