Ran 5 1/2" 15.5# J-55 casing with HOWCO float collar & float shoe to 3420'. Cemented w/200 sax @ shoe and 200 sax thru 2-stage tool @ 1147'. Let set 48 hrs. Tested casing w/1000 psi for 30 min. before drilling out 2-stage plug. Test O.K. Drilled out 2-stage plug & tested w/1000 psi for 30 min. Test satisfactory. Drilled out to 5' below shoe & pressured up again w/1000 psi. Test satisfactory.
