1. 1/17/78 Spotted 35 sacks of cement from 3167' to 2975'.
2. 1/18/78 Displaced hole with 130 barrels of 9.5 pounds per gallon mud. Cut 7" casing at free point (1640').
3. 1/19/78 Pulled 56 joints of 7" casing. Spotted 40 sacks of cement at 1689'.
4. 1/20/78 Tagged top of cement plug at 1566'. Spotted 90 sacks of cement at 1450'.
5. 1/21/78 Cement went out into formation. Pumped in 2 sacks cottonseed hulls and 45 sacks of cement with 80# Quickseal.
6. 1/23/78 Top of cement at 1420'. Pumped in 2 sacks of cottonseed hulls and 75 sacks of cement with 60# of Quickseal.
7. 1/24/78 Top of cement at 1345'. Spotted 90 sacks of cement.
8. 1/25/78 Top of cement at 1203'. Set 10 sacks cement plug at surface.
9. 2/3/78 Welded steel plate on top of 9-5/8" surface casing.
