Drilled from surface to 305' w/12 1/2" hole, ran 8 5/8", 24' casing set @ 305', cemented w/175 sacks Lone Star Reg. cement. Cement was circulated to outside of surface and allowed to set 18 hours, nipples up, tested w/1000 cold water pressure for 30 minutes prior to drilling plug. No decline in pressure. Cement was circulated on 8 5/8" surface casing. Total depth 3820'

Propose to temporary abandon by filling hole with 10' mud, close hole at surface and clean up the location. Hole will be used by Hubble before permanently being abandoned.

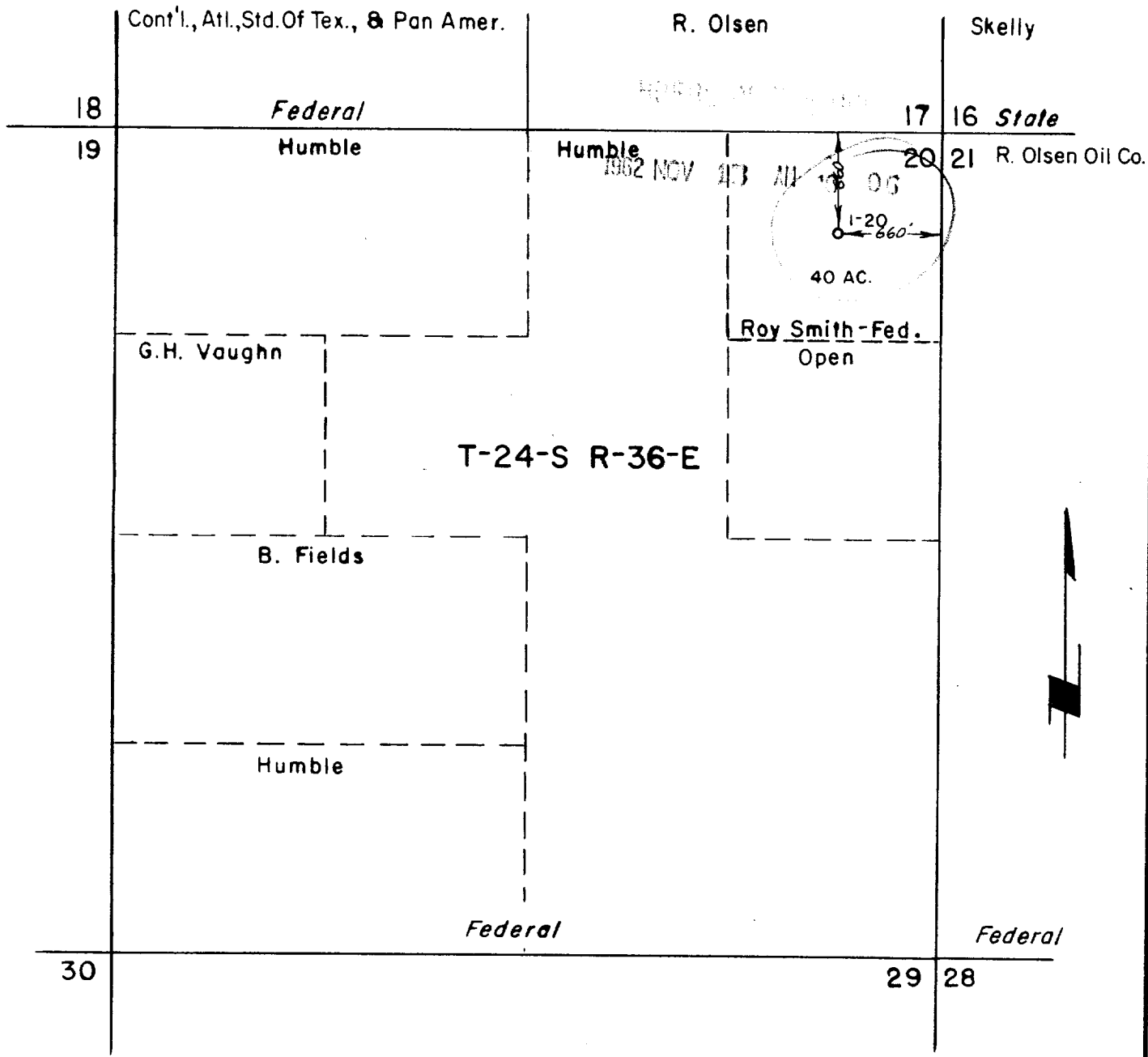
