5/28/73 Set bridge plug at 3190 and perforated 3030-3041 with 1 shot per foot. Treated with 1000 gallons mud acid. Pumped water off tubing, flowing gas off casing to El Paso's line. Water increased, drowing out gas. Found bridge plug leaking.

7/6/73 Set Baker lockset plug at 3180. Pump load water.

7/30/73 Pump 1 barrel water with trace oil 24 hours, 70 MCF gas. Casing pressure 50#, tubing pressure 20#.

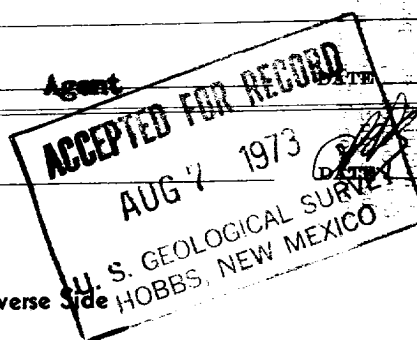

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
