DETAILS OF PROPOSED PLAN OF WORK

We ran Halliburton tester and set full hole packer at 3475' to take drill stem test. After the test we were unable to pull the testing tool and packer so we backed off the drill pipe leaving 18 fts. of 5" drill pipe, full hole packer, and testing tool in hole. We have recovered about 28' of drill pipe and we now propose to run a Baasch Ross Cut Off tool and cut off drill pipe 18" below the last collar. We will then set whipstock and drill by the packer and Halliburton testing tool.
