This well was plugged back to 3,272 feet in September, 1952 and perforated in the Yates zone from 3,056 to 3,250 feet. After acid treatment, the well reportedly produced a small amount of oil and gas. Attempts to produce the well since that time have proven non-commercial. We propose to log and possibly re-perforate a portion of the Yates zone and frac with 50,000 gallons and 50,000 pounds of sand.

We would like to start this work on June 1, 1964.

Instructions
