Elevation: 2953'. Total Depth 3177'. Formation Record: Top Anhydrite 1080', Base Salt 2590', Top Yates 2780', Top Reef Dolomite 2970. 8 5/8" casing set at 1172' and cemented to top. Halliburton Drill-Stem tests as follows: 2760-2980, showed 150' rotary mud, no cil, gas; 2970-3025, showed estimated 20 bbls sulphur water per hour & very little gas; 3032-3080, showed 2280' of sulphur water with 112,000 cu.ft. gas daily; 3048-3177. estimated 15 bbls water per hour, no oil, gas 120,000 cu.ft. daily. In the absence of any cil, and with such a small amount of gas, propose to plug and abandon in following manner: Cement from T.D. to 2760', mud to 2590' (Base salt), place 5' cement plug at that point, mud to bottom of 8 5/8" casing and place 5' cement plug, mud to top of hole and cap with commont, placing the regulation 4" pipe marker.
