Detailed account of work done, nature and quantity of materials used, and results obtained.

This well was drilled to 1540' in Anhydrite. Ran 50.3 jts (1532.8') of 8 5/8" OD 24# J-55 SS casing set at 1540. Cemented w/190 sacks regular cement mixed w/190 sacks diamix A and 12 sacks gel followed w/200 sacks reg. neat cement. Plug was down at 2:45 PM, October 13, 1959. Cement circulated. Cement was allowed to set 30 hours before testing for shut-off. Prior to and after drilling plug, tested with 1000# during a 30 minute interval with no drop in pressure.
