Pulled 2" tubing and set Baker Model "N" Cast Iron Bridge Plug at 5800' (PBD 5800'). Perforated 5 1/2" O D casing 5180-5240', 4 shots per foot. Acidized through 5-1/2" OD casing perforations 5180-5240' with 500 Gal. mud acid.

Completed well and started pumping well with 54" strokes, 16 strokes per minute. Pumped 24 hours 503 Bbls. water.
