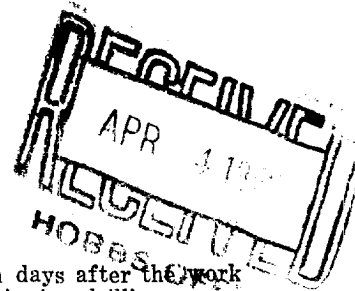

T.D. 3805' - Pulled 8 5/8" and 7" Casing. Filled with mud to 3600'. Sed bridging plug and dumped 10 sax cement. Same procedure for plugs @ 2550', 1330', 15 sax plug 760, 10 sax @ 325'. 10 3/4" Csg. cemented @ 325' with 150 sax cement. Regulation marker set at surface. Cellar & pits levelled.
