Hot oil well prior to workover. Rig up, pull rods and tubing, check fill up, clean out to total depth. Run 3" frac tubing with packer and holdown. Packer seat at approximately 3515'. Treat w/30,000 gal. sand oil, 60,000 lbs. sand, leave shut in overnight, pull frac tubing and rerun 2 1/2" tubing and rods and place on pump. Test.
