1. Pulled rods, pump and tubing.
2. Ran steel line measurement. Cleaned out from 3440-3642'.
3. Treated open hole formation from 3448-3680' with 15,000 gallons Control Frac with gel and 1-1/2# sand per gallon.
4. Reran tubing, rods and pump. Recovered all lead oil. Pumped 10 bbls oil, no water in 24 hours.
