Gentlemen:

Texas Pacific Coal and Oil Company respectfully requests administrative approval under provisions of rule 5 (c) of Order No. R-1670 for the formation of a 320 acre non-standard gas proration unit for its Clift, Well No. 5, located 660 feet from the west line and 1980 feet from the south line of Section 8, Township 23 South, Range 37 East, Lea County, New Mexico, in the Jalmat Gas Pool; and in support of this request states:

1. The proposed non-standard unit consists of the south half of Section 8, Township 23 South, Range 37 East.
2. The unit consists of contiguous quarter-quarter sections which lie wholly within a single governmental section.
3. The entire unit may reasonably be presumed to be productive of gas.
