- 1) Move in pulling unit. Pull tubing and packer.
- 2) Clean out inside 5" OD temporary liner, and pull liner.
- 3) Clean out open hole to 3625' TD.
- 4) Run approximately 325' of 5" OD liner with TIW Type "L" hanger 3300-3625'.
- 5) Cement liner and WOC 24 hours.
- 6) Drill out to top of liner and pressure test.
- 7) Clean out inside 5" OD liner to 3625' and pressure test.
- 8) Perforate 5" OD liner with one shot per foot at the following intervals:
3558-3564', 3574-3584', 3587-3594', 3596-3610', and 3613-3617'.
- 9) Treat perforations 3558-3617' with 2000 gallons of 15% acid.
- 10) Run injection tubing and packer.
- 11) Circulate with water treated with inhibitors. Set packer.
- 12) Connect to injection system and resume injection.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
