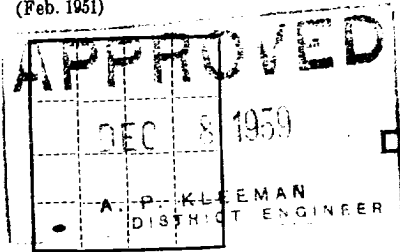

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

Plan to rotary drill a 11 1/4" hole and set 8 5/8" 24# casing at 375' and cement to surface. The well will then be rotary drilled to estimated depth of 3700' with a 6 3/4" hole and set 4 1/2" 9.5# oil string casing at total depth. The oil string will be cemented with 200 sacks and then cemented with 150 sacks through a stage tool set at approximately 1125' to isolate the Santa Rosa water zone from Salt Section. Top of salt estimated 1190', top of Queens estimated 3490'.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
