Abstract—The purpose of this study was to determine if there were differences in the prevalence of musculoskeletal disorders between two groups of nurses working in different units of a tertiary care hospital. The prevalence of musculoskeletal disorders was determined by means of a self-administered questionnaire among 100 nurses from the intensive care unit (ICU) and 100 nurses from the medical-surgical unit. The prevalence of musculoskeletal disorders was higher among ICU nurses than among medical-surgical nurses. The prevalence of musculoskeletal disorders was higher among nurses who worked longer shifts, had more years of experience, and used forceful exertion.
