DETAILS OF WORK

This well has been shut-in since 1939.

We propose to run bailer on sand line and cleanout to 3650' w/bailer, run bailer with cement and spot a 10' cement plug from 3640-3650', run 2 1/2" test tubing with open packer, set packer at approx. 3560', sandfrac through 2 1/2" tubing with 10,000 gallons of L. C., 15,000 lbs. sand, 500 lbs. "ADONITE", shut in overnight, pull 2 1/2" tubing, run 2" tubing, swab load and test well and place on production.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
