### DETAILS OF WORK

Will drill 11" hole to approximately 600'. Set and cement to surface 600' of 8-5/8" 24# casing. Drill 7-7/8" hole w/water to 3400' and mud up system. Continue to drill to approximately 3700' or through Permian formation. Set 5-1/2" 15.5# casing and cement to 1100' w/520 sack cement. Perforate Permian section and sand-oil fracture for completion w/3600' 2" LUE 4.7# tubing in casing.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

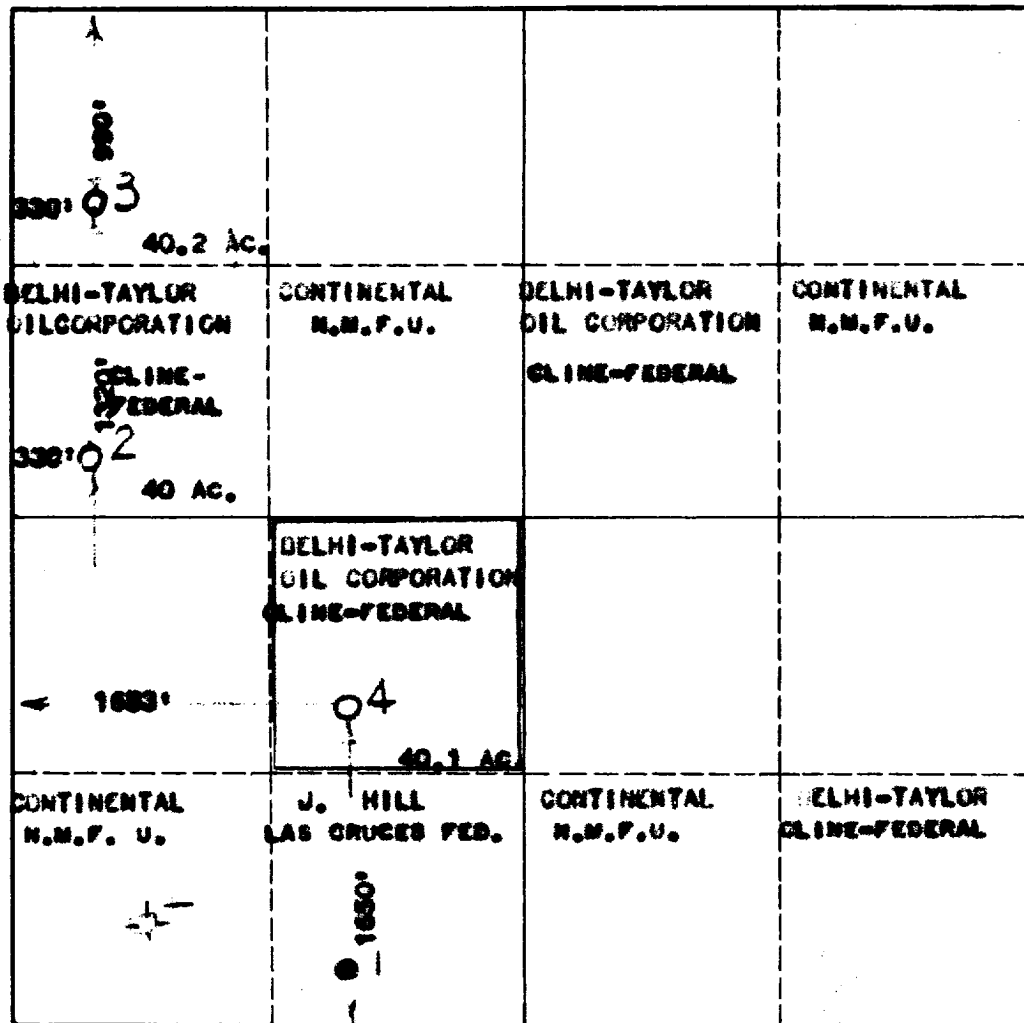
