
DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled to TD 300' reamed to 255' and cemented 13" OD casing w/ 250 sacks cement and 2 sacks Aquagel, circulating back to surface. Let stand 48 hours then drilled plug and tested casing shutoff with 1000# pressure for 45 minutes - Shut off O.K.
