This well was dead for some six months. Repeated swabbing did not help. On Dec. 15, 1976, tubing was pulled. Well was sandpumped to original T.C. of 3668. Tubing was run to 3600 with seating nipple and perforated nipple. Rods were run with insert pump. Well was put on production Dec. 26, 1976 with pump jack. C-115 special test was run 1/3/77 and copy of same is filed with this report.
