Propose to wash out sand-fill in the 5" OD liner to FBD 9437', run 2-3/8" Od internally plastic-coated tubing and Baker Model "R" packer, set same in the 7" OD casing at approximately 9200', and put well on water injection. The Gulf LaMunyon Teague waterflood project was approved by New Mexico OCC Order No. R-3297 dated 8-15-67.

This well has been in a temporary abandoned status.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
