

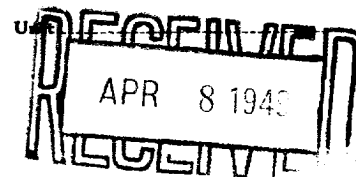

DETAILS OF WORK

On March 22, 1949, DST @ TD 7463' w/8" packer set @ 7289'. Halliburton tool open 1 hr w/15 minute BU (5/8" SS & 1" S choke). 1,062,600 CF gas to surface in 8 minutes, mud and water in 16 minutes. Flowed into pit for 30 minutes, and then flowed 20 bbls of mud and water w/show of oil into test tank in 30 minutes. Gas increased to 1,881,510 CF at end of test.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
