Went in hole with 12-1/4" bit, drilled 8' surface plug, washed to 185', drilled cement to top of 9-5/8" csg. Ran 8-3/4" bit and drilled cement 2790-2913'. Cleaned out mud and trash to 3207'. Ran 6-1/8" bit, drilled wood and cement to 3282'. Dialog caliper survey did not locate top of 7" casing. Went in hole with 8-3/4" bit and drilled to 3265'. Schlumberger caliper log indicated logging tool outside casing. Ran tapered mill and kick sub. Could not work mill inside of casing. Installed 13-3/8" csg flange on head. Operations temporarily suspended. Hole sidetracked to 3265' with 8-3/4" bit. Will apply for permit to sidetrack well.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
