1. Rig-up Pulling Unit and install BOP.
2. Load hole with 10#/gallon brine.
3. Set 4" CIBP on wireline at 5000' and dump 35' cement on top with dump bailer.
4. Run workstring and spot a 100' cement plug at 4000' to 4100' across 5-1/2" casing shoe.
5. Pull-up and spot a 100' cement plug at 3250' to 3350' across the top of liner.
6. Pull-up and spot a 100' cement plug at 2850' to 2950' across 8-1/2" casing shoe.
7. WOC 24 hours.
8. TOH with workstring.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices. 9. Perforate 5-1/2" casing at 1200' with 2 holes using 1-9/16" decentralized gun.
10. Rig up and pump cement down 5-1/2" casing. Circulate cement up 5-1/2" - 8-5/8" annulus.
11. Install dry hole marker.

PRIVACY ACT
