Reference is made to your application for permission to flare gas on your Melba Goins lease consisting of the E/2 SE/4 of Section 27, Township 23 South, Range 37 East, NMPM, Lea County, New Mexico.

In your application you have made reference to wells No. 1, 2-A and 3, however the request for permission to flare referred only to the Goins Well No. 2-A.
