DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

After waiting 48 hours, the casing was tested with 1000# of pressure applied for 30 minutes. The plug was drilled and the casing and cement tested with 1000# pressure applied for 30 minutes. Both tests were OK with no drop in pressure, and after approval of Mr Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.

Company survey indicated top of cement back of 9 5/8" casing at 1850'.
