Propose to plug off lower Blinbry perforations 5878' to 5620' by setting a Cast Iron Baker Model "N" bridge plug at 5630'. The present Blinbry completion is producing gas and condensate. The proposed recompletion should result in an oil well and subsequent re-classification of the well. The Blinbry formation will be perforated between 5370' and 5618', selectively acidized and fractured.
