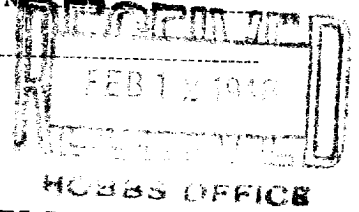

### DETAILS OF WORK

Report of Coring: Core #16 - 9463' to 9507' - cutting time 8 hrs. 51 min., recovered 44'. - Top 14' clean fine to medium coarse porous sand - light saturation. Next 5', sandy green clay shale. Next 8', clean fine to medium coarse porous sand - barren. Top 1' and basal 6" white very fine sand, well cemented. Next 11' Variably fine to medium coarse porous sand. Clean - fair saturation. Basal 6', firm white very fine sand, well cemented. Barren - basal foot green very shaly sand.
