In October, 1974, the U.S.C.S. approved temporary abandonment of this well until November 1, 1975. The well was temporarily abandoned at an unknown date by the former operator as uneconomical to operate prior to unitization into the Myers Langlie-Mattix Unit 2-1-74. Present plans are to place the well in an active operating status in the second or third quarter of 1976. Skelly Oil Company respectfully requests that a one year extension to temporarily abandon this well be granted administratively as per New Mexico Oil Conservation Commission Order No. R-5019. Water injection is presently being expanded on this unit.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
